

# 2024 Foundations Five-in-Five Contest

## OFFICIAL RULES

**NO PURCHASE OR DONATION NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING.**

**THIS CONTEST IS GOVERNED EXCLUSIVELY BY THE LAWS OF THE UNITED STATES. YOU (ALSO SOMETIMES REFERRED TO AS “ENTRANT”) ARE NOT AUTHORIZED TO PARTICIPATE IN THE CONTEST IF YOU ARE NOT LOCATED WITHIN THE FIFTY (50) UNITED STATES, THE DISTRICT OF COLUMBIA, OR PUERTO RICO.**

### **SPONSOR**

Wilson Language Training Corporation – 47 Old Webster Road, Oxford, MA 01540 (“WLT” or “Sponsor”).

### **1. CONTEST PERIOD**

Contest begins at **12:00:01 am Eastern Time on March 12, 2024, and ends at 11:59:59 pm Eastern Time on April 30, 2024** (the “Contest Period”).

### **2. ELIGIBILITY**

Contest is open only to legal residents of the fifty (50) United States, the District of Columbia, and Puerto Rico, who are twenty-one (21) years of age or older as of the date of entry and is void where prohibited, taxed, or restricted by law. All federal, state, and local laws and regulations apply.

Employees of WLT and affiliate companies and their respective advertising and promotion agencies, consultants, board members, directors, and agents, as well as immediate family members and/or those living in the same household of each such person, are not eligible to participate. “Immediate family member” shall be deemed to mean husband, wife, child, mother, father, sister, sister in-law, brother, or brother in-law.

WLT reserves the right to permanently disqualify from this Contest any Entrant it believes has violated these Official Rules, and to verify eligibility of Entrants.

WLT reserves the right to permanently disqualify from this Contest any entries (and Entrant) not carefully completed or submitted within the minimum standard of care, as determined by WLT at its own discretion.

There is a limit of one (1) Contest entry per person.

WLT may reach out to Entrant with information about WLT's products and services.

#### 4. SELECTING WINNERS

On or about May 15, 2024, prize winners will be selected from all eligible entries received by WLT. WLT will designate an internal committee that will evaluate all entries and select the winners.

There will be five (5) selected winners. Winners will be responsible for presenting the slides in person on Thursday, July 25, 2024, at the Foundations Conference at Hilton® Boston Park Plaza in Boston, MA.

#### 5. PRIZES

**PRIZE:** Each of the five (5) winners will receive one (1) free entry to the 2024 Foundations Conference (tuition only).
