OFFICIAL RULES

1. CONTEST PERIOD

Any attempt by any Entrant to obtain more than the maximum number of allowable entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that Entrant's entry and may result in disqualification of that Entrant. In the event of a dispute regarding a specific registration, the authorized account holder of the email address used to register will be deemed to be the Entrant.
